What is the purpose of this update?

This document tells you how the Cash Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The Trustees of the Sovereign Staff Retirement Fund prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of the fund

The Cash Fund is more suitable for risk-averse investors looking for a very stable low-risk return for a short period. As the fund only invests in income-producing asset classes, the opportunity to provide long term capital growth is extremely limited.

The performance objective of the fund is to provide a total return that exceeds the S&P/NZX 90-Day Bank Bill Index before tax and fees over rolling three year periods.

What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

*Fund charges for the year ending 31 March 2018 are expected to be nil as they will be paid from the Scheme's unallocated balance from 1 April 2017.


Example of how this applies to an investor

John had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, John received a return after fund charges were deducted of \$181 (that is 1.81% of his initial \$10,000). John did not pay any other charges. This gives John a total return after tax of \$181 for the year.

What does the fund invest in?


Actual investment mix
