Fund Update for the year ended 31 March 2017

What is the purpose of this update?

This document tells you how the Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The Trustees of the Sovereign Staff Retirement Fund prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of the fund

The Growth Fund gives members the opportunity to gain exposure to a diversified, medium/high risk portfolio of investments. The fund invests in International and Australasian equities and quality New Zealand and offshore fixed interest securities and cash. The fund would suit members wishing to obtain exposure to an investment fund comprising mainly growth assets.

The performance objective of the fund is to provide a long term real return of inflation plus 3.25% p.a. where inflation is measured by the Consumer Price Index. The Growth Fund invests in the ANZ Investments Multi-Asset-Class Scheme Growth Fund.

What are the risks of investing?

Risk Indicator for the Growth Fund

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

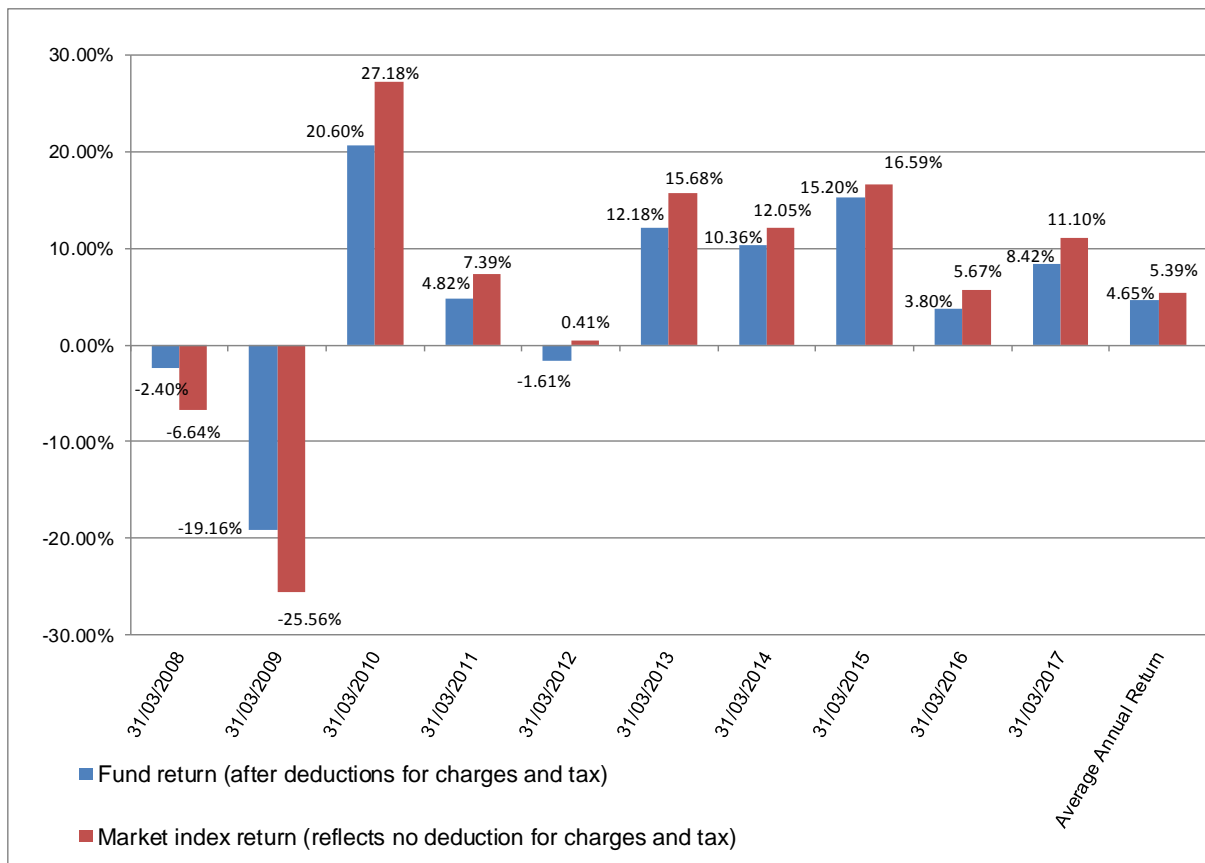
The risk indicator is not a guarantee of a fund's future performance. The risk indicator is based on the returns data for a 5 year period to 31 March 2017. While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

How has the fund performed?

The market index return is based on the target investment mix asset allocation weighted sum of the asset class market index return over the period. Annual return graph



This shows the return after fund charges and tax for each of the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 31 March 2017.

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). These fees are not currently charged for the Growth Fund.

Small differences in fees and charges can have a big impact on your investment over the long term.

*Fund charges for the year ending 31 March 2018 are expected to be nil as they will be paid from the Scheme's unallocated balance from 1 April 2017.

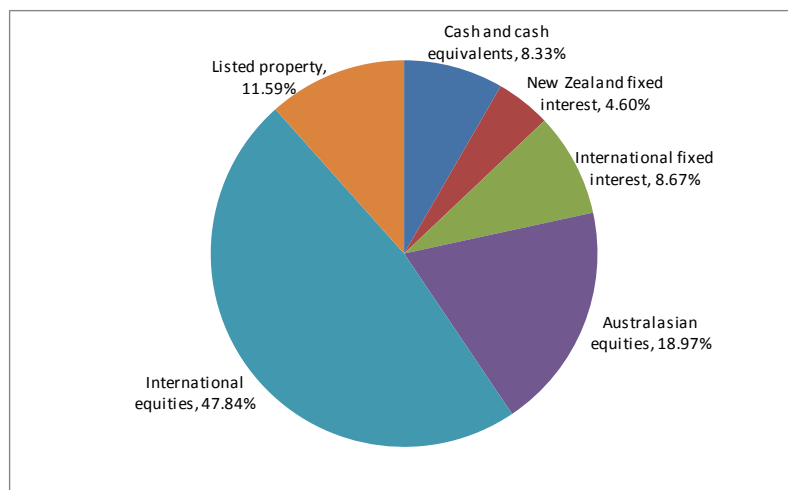
Example of how this applies to an investor

John had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, John received a return after fund charges were deducted of \$842 (that is 8.42% of his initial \$10,000). John did not pay any other charges. This gives John a total return after tax of \$842 for the year.

What does the fund invest in?

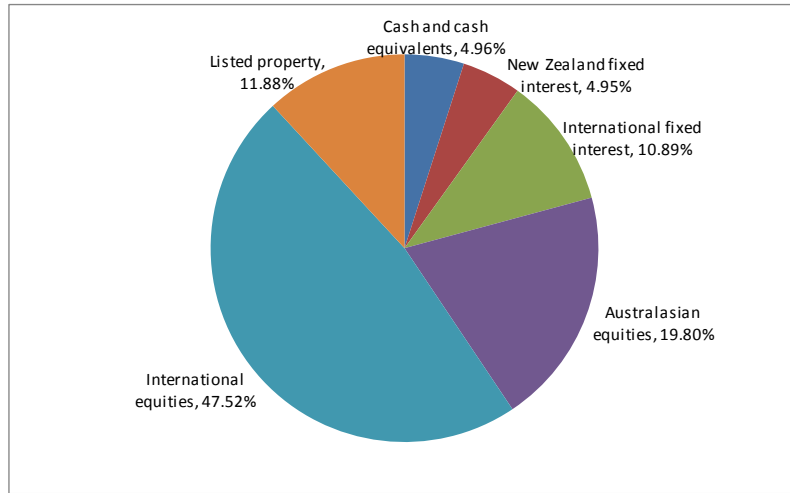
Actual investment mix¹
