What is the purpose of this update?

This document tells you how the Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The Trustees of the Sovereign Staff Retirement Fund prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Conservative Fund invests in quality New Zealand and offshore fixed interest securities and cash. The fund may also have a small exposure to Australasian and International Equities. This is to ensure that the fund can achieve a modest level of growth over the long term. The fund is more suitable for risk-averse members seeking stability with the ability to achieve some growth over the long term. It would suit members approaching retirement who wish to reduce the possibility of negative returns.

The investment objective of the fund is to provide a long term real return of inflation plus 1.75% p.a. where inflation is measured by the Consumer Price Index. The Conservative Fund invests in the ANZ Investments Multi-Asset-Class Scheme Conservative Balanced Fund.

What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.



Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

John had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, John received a return after fund charges were deducted of \$1,389 (that is 13.89% of his initial \$10,000). John did not pay any other charges. This gives John a total return after tax of \$1,389 for the year.

What does the fund invest in?


Actual investment mix 2
